Lower Susquehanna Synod Disaster

Response Network Focuses on Long-Term Recovery Work

"God is our refuge and strength, an ever-present help in trouble. Therefore we will not fear, though the earth should change, though the mountains shake in the heart of the sea." Psalm 46:1-2

Long after the headlines change and the devastation from Hurricanes Harvey, Irma and Maria becomes a distant memory for those not directly impacted, Lutheran Disaster Response volunteers will arrive at disaster sites with a focus on long-term recovery.

The local Lutheran Disaster Response affiliate – the Lower Susquehanna Synod Lutheran Disaster Response Network – completed more than half a dozen disaster response trips this year to West Virginia and other places, seeking to speed up the time it takes for victims of disaster to return home once again. A local group from northern Lancaster County just completed one final disaster response trip to New Jersey, five years after Superstorm Sandy ravaged the East Coast. Next, we'll turn our sights toward providing ongoing assistance to the south.

The Lutheran Disaster Response (LDR) Network has an extensive history of responding to disasters, both in the United States and internationally. From its inception, LDR made a commitment to the long-haul. We are on site when disasters occur because the work that is

done through LDR is indeed the very work of the church.

The LDR Network provides support in several ways: recruiting and coordinating volunteer teams who help clean up and rebuild; case management; construction estimation; emotional and spiritual support and seeking to build and maintain community resiliency. Volunteers work in partnership with other local agencies and alongside partners from other not-for profit organizations who are active in disaster response.

Every disaster, no matter the size or scope, is a local event and the response to that event is rooted in the local community.

Luther Acres, Spang Crest Healthcare Centers Earn 5-Star Ratings

The Healthcare Centers of Luther Acres and Spang Crest have each earned the highest rating possible by the U.S. Centers for Medicare & Medicaid Services (CMS).

The skilled nursing centers, located in Lititz and Lebanon, earned an overall 5-star rating from the CMS, in accordance with the standards set forth by the entity.

"We are extremely proud to have received five-star ratings at both of our healthcare centers, and it is a direct result of the dedication and commitment to excellence that our entire team puts forth every day in providing superior care to each resident whom we serve," said Matthew Oathout, Luthercare's Senior Vice President of Operations.

The Five-Star Quality Rating System was created "to help consumers, their families, and caregivers compare nursing homes more easily and identify areas about which you may want to ask questions," according to the CMS website. Skilled nursing centers receive a rating of between one and five stars, with five stars being considered to have much-above-average quality. The rating takes into account three sources of information: health inspections based on outcomes from state inspections; staffing levels; and quality measures, which look at physical and clinical measures for residents.
